FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 23


The Board of Directors of Fort Bend County Municipal Utility District No. 23 will hold a regular meeting on **Thursday, March 27, 2025, at 5:30 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, Phoenix Tower, 3200 Southwest Freeway, Suite 2400, San Jacinto Room, Houston, Texas*, to discuss and, if appropriate, act upon the items listed below:

1. Public comments (maximum 3 minutes per person).**
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event the item will be removed and placed on the Non-Consent Agenda.
 - a. Approve minutes.
 - b. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
 - c. Operation of District facilities, including billings, repairs and maintenance, customer correspondence, message language on bills, and delinquent back charges.
 - d. Garbage and recycling matters.
 - e. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training and public comment.
3. NON-CONSENT AGENDA
 - a. Items removed from the Consent Agenda.
 - b. Approve audit for fiscal year end December 31, 2024.
 - c. Update on temporary interconnect water service provided to the City of Missouri City.
 - d. Parks and recreational facilities matters, including:
 - i. update on pending repairs and authorize additional repairs and improvements as appropriate;
 - ii. design of park facilities, plan approval, advertisement for bids, contract award, and pay estimates for park construction projects, including:
 - aa. 10-acre park tract;
 - iii. update on Master Park and Trail Plan; and
 - iv. Texas Parks and Wildlife Recreational Grant.
 - e. Financial and bookkeeping matters, including payment of bills and review of investments.
 - f. Consider amendment to tax assessor/collector's agreement.
 - g. District energy contract matters, and take appropriate action.
 - h. Donation Agreement for West Sycamore Road.

- i. Engineer's report, including:
 - i. authorize design of facilities, approve plans and specifications and authorize advertisement for bids for projects in the District, including:
 - aa. waterline and sanitary sewer extensions along South Post Oak Boulevard;
 - bb. Teal Run Estates Drainage Channel Rehabilitation; and
 - cc. Water Supply Plant No. 1 Automatic Transfer Switch and Generator replacement;
 - ii. review bids and award contracts for projects in the District;
 - aa. wastewater treatment plant improvements;
 - iii. approve pay estimates, change orders and final acceptance as appropriate;
 - aa. 16-inch water line installation on Buckwood Court;
 - iv. consider request from Fort Bend County Municipal Utility District No. 24 to borrow excess water capacity from the District pending construction of the new water plant.
 - v. proposal for rerating the wastewater treatment plant;
 - vi. Capital Improvement Plan;
 - vii. South Post Oak Boulevard extension, including sidewalks and CenterPoint easement agreement;
 - viii. Lake Olympia Parkway;
 - ix. Chimney Rock Road;
 - x. Westenfeldt Road;
 - xi. West Sycamore Road;
 - xii. deeds, easements, consents to encroachment, requests for service or utility commitment requests, including conveyance of various tracts to the District;
 - xiii. expansion of the regional water system;
 - xiv. Fort Bend County drainage matters;
 - xv. annexation matters; and
 - xvi. development in the District.
- j. Review Emergency Preparedness Plan and authorize filing of updates, if necessary.
- k. Review Critical Load Spreadsheet for District's facilities and authorize annual filing.
- l. Additional operating matters, including:
 - i. hearing on the termination of water and sewer service to delinquent customers, authorize termination of service, and process uncollectible accounts as applicable;
 - ii. approve and authorize operator to file annual water loss audit;

- iii. approve annual report on implementation of Water Conservation Plan and authorize submittal to the Texas Water Development Board;
- iv. conduct annual review of Drought Contingency Plan; and
- v. conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment.
- m. Update on wastewater treatment plant oxidation ditch repair insurance reimbursement.
- n. Update on deed restriction violations concerning commercial tract.
- o. District security matters.
- p. Administrative manager/building matters.
- q. District website and communication matters, including approve related proposals and correspondence.
- r. Discuss District amenities operation and maintenance matters, including the tennis courts and detention ponds, and take appropriate action.
- s. Discuss 2025 Water Conservation Program/Shred Event.
- t. Reports from Directors and District consultants on District operations.
- 4. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer.
- 5. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation, or a settlement offer.

**** A statement of no more than 3 minutes may be made of items of general relevance or related to items listed on the posted meeting agenda. There will be no yielding of time to another person. State law prohibits the Board from commenting on any statement or engagement in dialogue without an appropriate agenda item being posted in accordance with the Texas Open Meetings Act. Comments should be directed to the entire Board, not individual members. Engaging in verbal attacks or comments intended to insult, abuse, malign, or slander any individual shall be cause for termination of time privileges.**
